On January 1, 2024, we received a Consumer Financial Protection Bureau complaint letter submitted by a customer regarding her overdrawn accounts and the recent conversion from Mechanics Bank to BankFirst. As a courtesy, the bank refunded the fees that had been charged to her account and provided assistance at the local branch to bring the customer's accounts to a current status.

We are so grateful to have Rashni Barath as a member of the Autism Center's Board of Directors. As a board member, she provides legal governance and financial management policies to ensure ACNM has adequate resources to advance its mission. With her banking and finance background, Rashni has the skills to provide insight and guidance when reviewing our monthly financial statements. She is also passionate about our cause which motivates her to help with fundraising.

The mission of ACNM is to provide hope, support, and empowerment to persons at all levels of the autism spectrum and their families through the science of Applied Behavior Analysis. We currently serve 58 children ages 18 months to 10 years old. We also provide resources and parent training to 116 families on our waiting list.

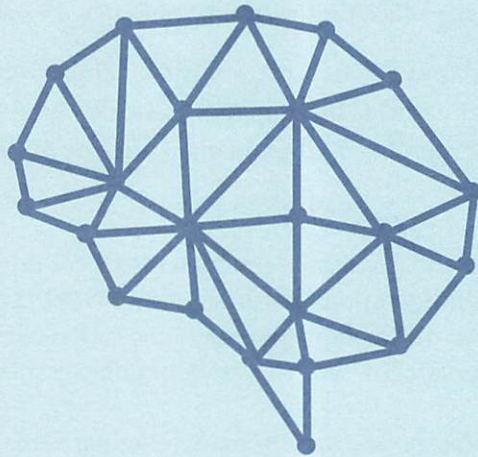
ACNM receives insurance and Medicaid reimbursements for our services. However, over 78% of our children have Medicaid as their primary insurance, and ACNM is the only ABA clinic in north Mississippi that sees Medicaid clients. This means that for services that cost us \$18 per unit to provide, we receive \$12.98 per unit in reimbursement. We rely on donations, grants, and fundraisers to cover the deficit.

We are blessed to have Rashni, and we are thankful to BankFirst for allowing her to share her time and expertise with us.

To Whom It May Concern:

The Mission of the Regional Rehabilitation Center is to, at no cost to the individual, restore and enhance the quality of life of North Mississippians with disabling conditions through rehabilitation services characterized by quality care and personal attention. The Regional Rehab Center is a non-profit rehabilitation center located in Tupelo that provides physical therapy, occupational therapy, speech therapy, audiology services and early intervention services. All services are provided by licensed therapists at no cost to the client or their insurance company. There is neither a socio-economic requirement nor a sliding scale fee. More than 50% of the clients seen at RRC are from low to moderate income. This past year the Regional Rehab Center was able to help 1,629 people from 18 counties in Mississippi, 4 from Alabama, and 1 from Tennessee.

We are very proud to have Rashni Barath serve on our Board since 2018. Rashni has volunteered for 3 hours on RRC's Board from January 1, 2023, through July 28, 2023. Rashni has volunteered for the RRC's Finance Committee for 3 hours from January 1, 2023, through July 28, 2023. Rashni has volunteered for RRC's Nominating Committee for 3 hours from January 1, 2023, through July 28, 2023. The volunteer hours for the fundraisers equaled 21 hours from January 1, 2023, through July 28, 2023, which gave Rashni a total of 30 volunteer hours with RRC in 2023.
